As per the directive, no fresh admissions shall be made to the existing Four-Year Integrated Teacher Education Programme (i.e., B.A. B.Ed. and B.Sc. B.Ed.) from the academic session 2025–26, as the said course has been discontinued from this Academic Session.

Accordingly, the said programme has been removed from the SAMS UG portal for the Academic Session 2025-26. Applicants who have already submitted their Common Application Form (CAF) for this programme will have the opportunity to modify or change their subject choice during the CAF editing period.
